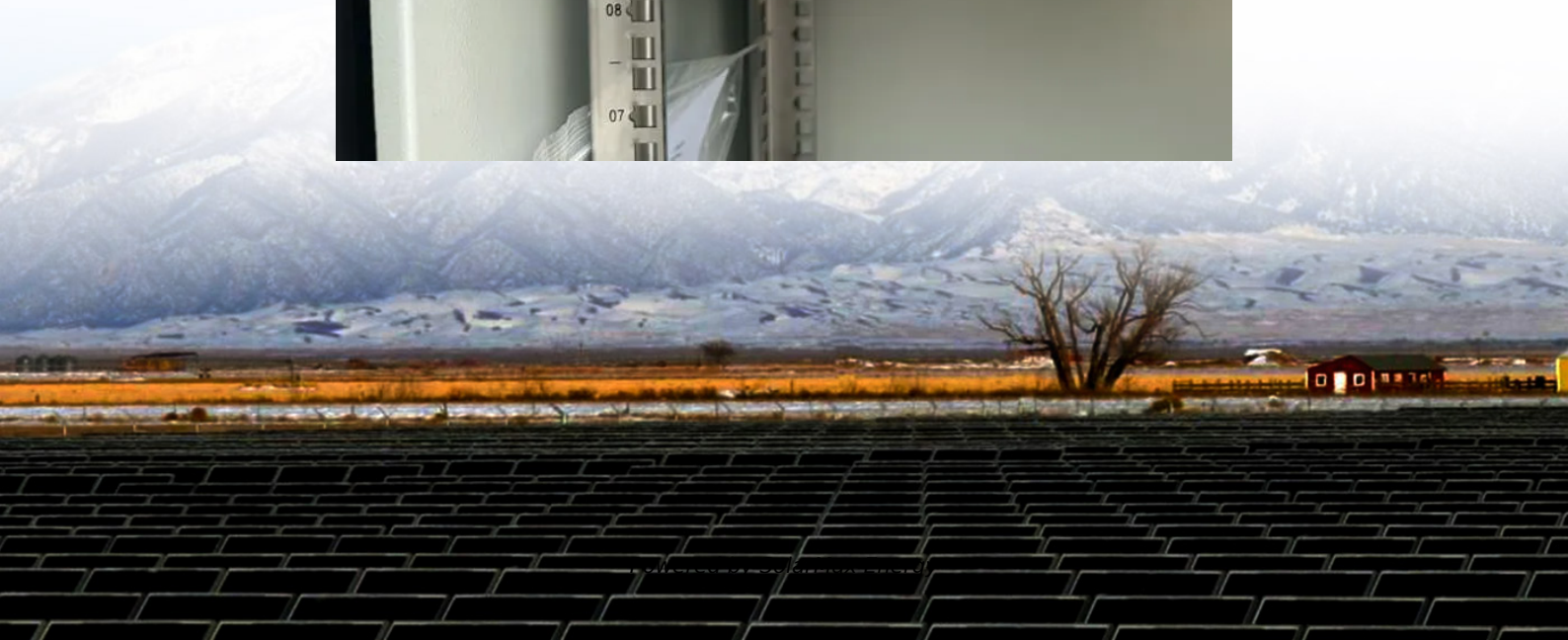

Overview

How did Trump's 2025 tariffs affect the Middle East?

Trump's 2025 tariffs triggered global economic and energy disruptions, indirectly impacting the Middle East. While Gulf states avoided major direct hits, risks to energy exports, macroeconomic uncertainty and global trade shifts present challenges, but also open market and policy opportunities.

The tariffs present Middle Eastern states with some opportunities, but pose major risks, especially to the energy sector. Analysing the tariffs is challenging. First, they follow on earlier measures, dating back to Trump's initial term in office, some retained by President Joe Biden.

How will the new tariffs affect the Middle East?

Middle Eastern countries like the UAE and KSA will face a 10% tariff, while others like Jordan and Iraq will face higher rates. Middle East businesses should evaluate the impact of the new tariffs, assess customs and trade options, monitor trade policy changes, implement compliance systems, and review legal obligations with suppliers.

Which MENA regions will not be affected by the new tariffs?

For instance, crude oil exports from Saudi Arabia, Iraq, and Libya, which represent a major share of their export revenues, will not be subject to the new tariffs.

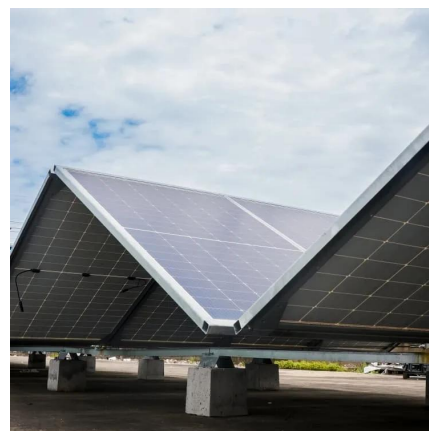

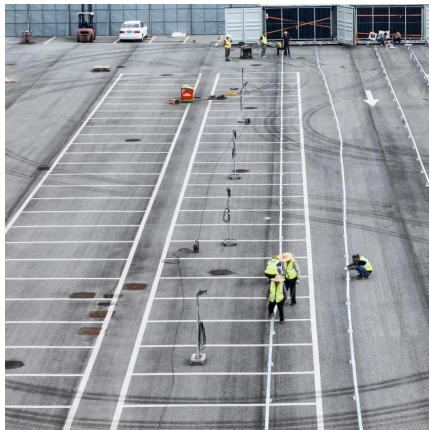

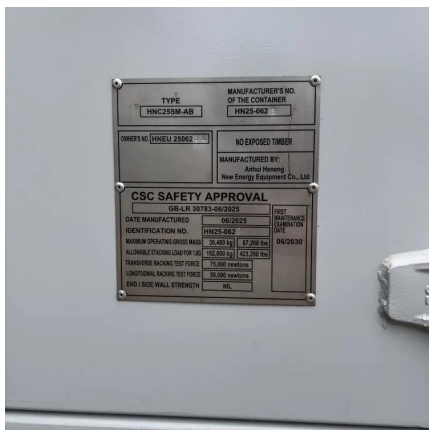
