Import and export regulations encompass various laws, guidelines, and procedures that dictate how goods can be brought into or shipped out of the country.

Who is responsible for exporting products to the Netherlands?

When exporting products to the Netherlands from outside the EU, your representative inside the EU is usually responsible for lodging the customs declaration. This officially turns the products from non-EU goods to EU goods. In some cases you can be responsible: for example, if you and your importer agree on the Incoterm® Delivered Duty Paid.



Is there a roadmap for energy storage in the Netherlands?





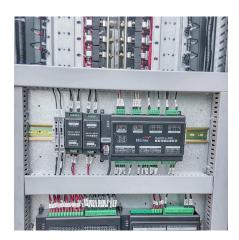
