What is solar energy storage future Philippines?

"Our mission is to connect stakeholders and drive tangible progress in Philippine renewable energy." Each year, Solar Energy Storage Future Philippines convenes government representatives, C-level executives, project developers, technology providers, financiers, and researchers.

What is the Philippine Energy Transition Strategy?

The Philippine Government will also establish the infrastructure for EVs, and formulated policies for the utilization of sustainable fuels. The Philippine Energy Transition Strategy will promote a range of export and investment opportunities across the clean energy sector including future civil nuclear and hydrogen generation.

Will Chinese energy companies invest in the Philippines in 2023?

In 2023, nine Chinese energy companies pledged USD 14 billion in investments for renewable energy projects in the Philippines, although no further announcements have been made since. Legislators have been pushing for a change to the Philippines' constitution to enable increased foreign investment.

Legislators have been pushing for a change to the Philippines' constitution to enable increased foreign investment. Under the existing constitution, most sectors maintain a 60%-40% ownership split favouring Filipinos.



Does the Philippines have a 60% ownership split?

Under the existing constitution, most sectors maintain a 60%-40% ownership split favouring Filipinos. However, this restriction has been bypassed in certain sectors, including energy, through specific legal provisions – raising questions about whether such constitutional changes are even necessary.


