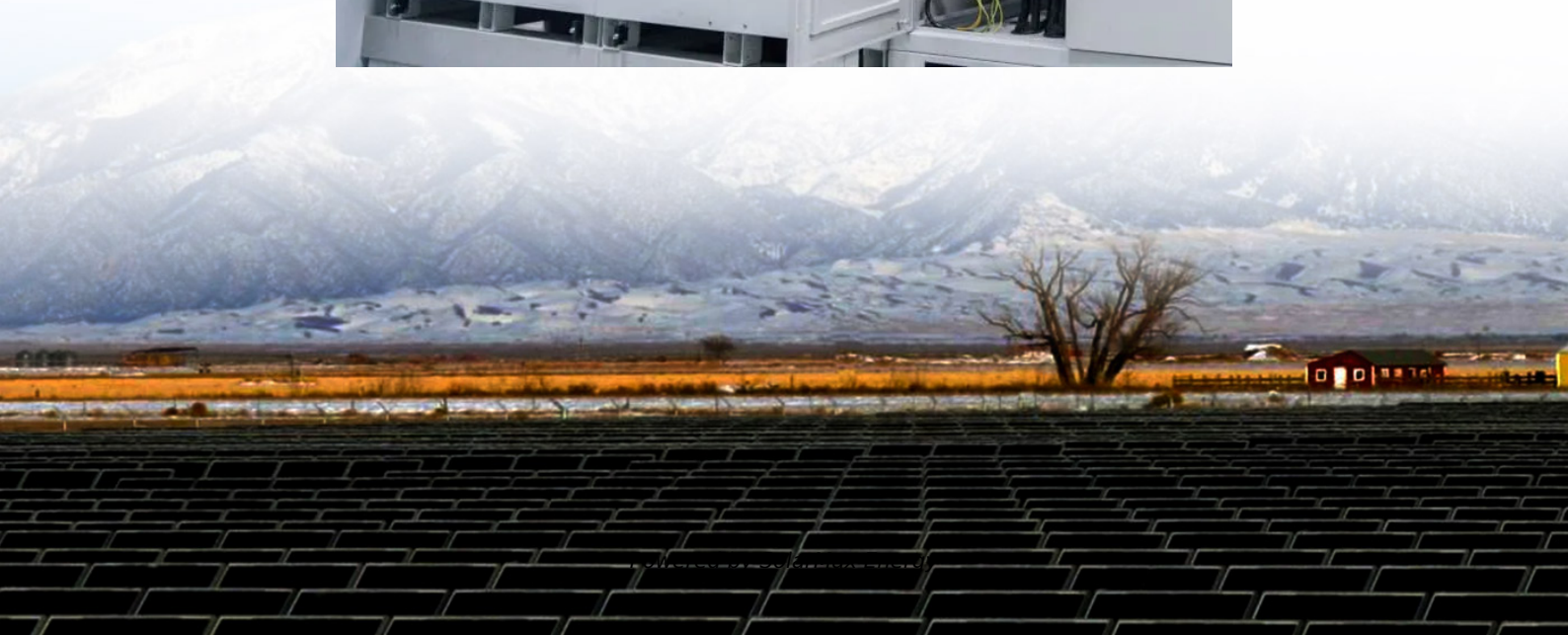


Solar panel content requirements





Overview

How much domestic content is required for energy projects?

Steel or iron used in these projects must be 100% domestically produced for the energy project to qualify as domestic content. Beyond that requirement, the remaining domestic content materials must add up to at least 40% of project costs (increasing to 45% in 2025).

How do solar developers calculate domestic content?

Instead of tracking down actual costs from manufacturers to use in domestic content calculations, solar developers can rely on the cost percentages provided by the IRS, adding up the component percentages to determine if a project will meet the total domestic content percentage requirement.

Do solar projects qualify for bonus tax credits?

The US Treasury updated a table last week that is used to calculate the domestic content of solar, onshore wind and storage projects to determine whether they qualify for bonus tax credits. The updated table is in Notice 2025-08. The updated table applies to domestic content calculations starting on January 16, 2025.

Are solar & storage projects a domestic content project?

Through the end of 2024, solar + storage projects are treated as one energy project for domestic content requirements. Depending on the mix of product options utilized, companies may qualify for the 10% domestic content bonus credit across the entire project via either the solar or storage portion of the project.

Should US solar panels have a higher domestic content?

At least two solar panel manufacturers with factories in the United States lobbied Treasury to assign a higher domestic content to solar modules that use not only US-made cells, but also US-made wafers.



How much mlpe can a rooftop solar system achieve?

Rooftop Solar MLPE projects can achieve a percentage of 44.4 with MLPE + racking and no domestic PV module. Unless new guidance says otherwise, this would still qualify a system for the domestic credit under the ITC, which is still a 40% APR. Rooftop with String inverters without a domestic module maxes out at a combined percentage of 30.8.
