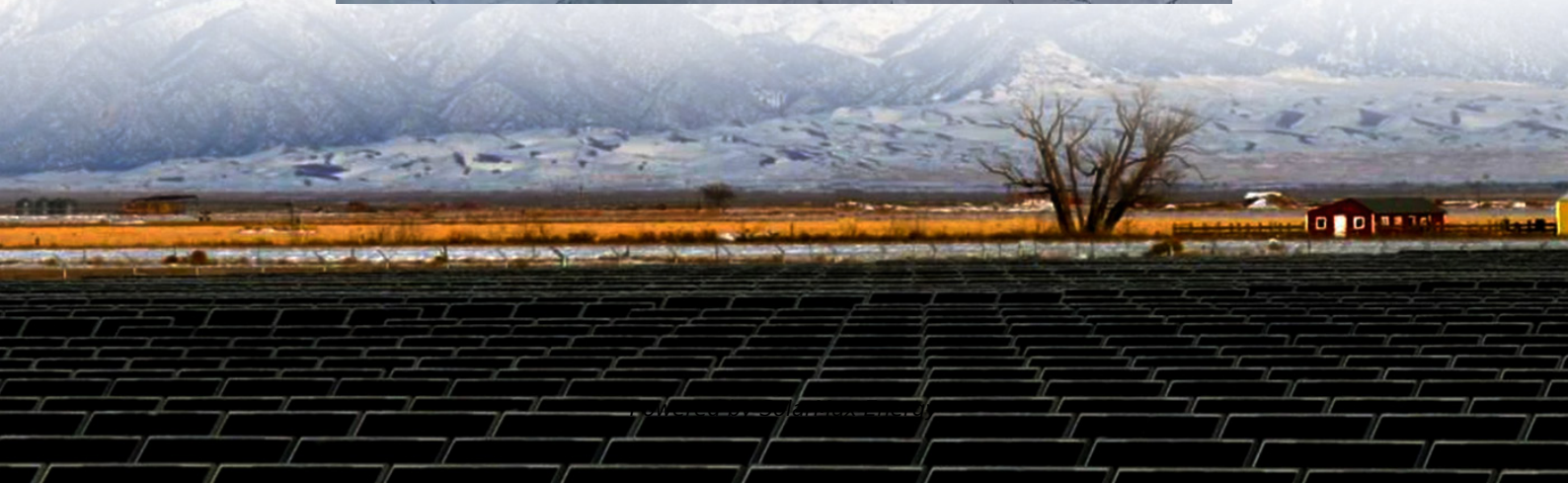

In addition to customs duties, imported goods are also subject to Value Added Tax (VAT). The VAT rate is 25% and is calculated based on the goods' CIF value and customs duty amount.



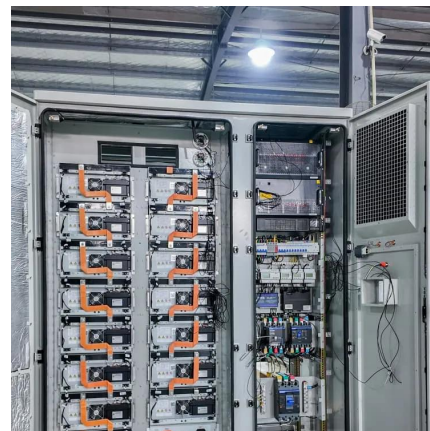
