What is PGST & other tax in Palau?

PGST & Other Taxes The Palau Goods and Services Tax (PGST) and Other Taxes In line with RPPL No.11-11, § 1283. Collection of PGST on imports, the BCBP must collect PGST payable under this chapter on a taxable import at the time of import and must, at that time, obtain the name and tax identification [.].

What is the Palau goods and Services Tax Act (PGST)?

"Act" is defined to mean the Palau Goods and Services Tax Act in Chapter 12 of Title 40. The Act imposes Palau Goods and Services Tax (PGST) on: (i) taxable supplies made by a registered person; (ii) supplies of imported services made to a registered person; and (iii) taxable imports by any person.

Are prohibited imports allowed in Palau?

Prohibited imports shall not be transported, stored, or released for use in Palau except as provided for in the laws under which their import is prohibited or restricted. 4.5.1.1 General Penalty.

Is a right or option a taxable supply in Palau?

The supply of a right or option is a taxable supply if it is made in Palau in the course or furtherance of a business carried on by the person who has granted the right or option and is not an exempt supply.

When can a machine be re-exported in Palau?

4.10.3.3 machinery for processing and are to be re-exported upon completion of the activity for which such item was imported, but in any case, no more than six months from date of first entry into Palau, the Chief of Customs may provide for the deferment of any applicable import tax for such period of time.



Can imported goods be unloaded from a conveyance arriving in Palau?

4.13.2 Unloading. Imported goods shall not be unloaded from a conveyance arriving in Palau until they have been reported under subsection 4.13.1 except where the safety of the conveyance is threatened by collision, fire, the stress of weather, or other similar circumstances.




