Overview

What tariff system does Nepal use?

Nepal uses the Harmonized Tariff System (HTS) for classification purposes. Import duty rates vary from zero to 80 percent. There is a two-tier tariff rate system for most imported items - one for imports from South Asian Association for Regional Cooperation (SAARC) nations, which is usually lower than for imports from all other non-SAARC countries.

How are import tariffs assessed in Nepal?

Import tariffs are generally assessed on an ad valorem basis. Nepal uses the Harmonized Tariff System (HTS) for classification purposes. Import duty rates vary from zero to 80 percent.

What is the level of energy consumption in Nepal?

Nepal's level of energy utilization is lower in comparison with other nations in South Asia. According to the recent financial survey for the fiscal year 2073/74 of Government of Nepal, there was 1.19 ton of oil equivalent² of energy consumed in Nepal for generating a gross domestic product of USD 1000.

What is the GDP of Nepal?

GDP of Nepal is 40,828,247,302.49 in current US\$. Nepal services export is 1,224,860,595.98 in BoP, current US\$ and services import is 1,978,875,677.38 in Bop, current US\$. Nepal exports of goods and services as percentage of GDP is 6.76% and imports of goods and services as percentage of GDP is 42.64%.
